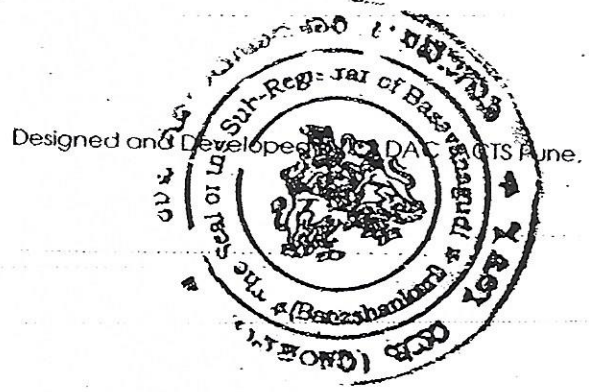

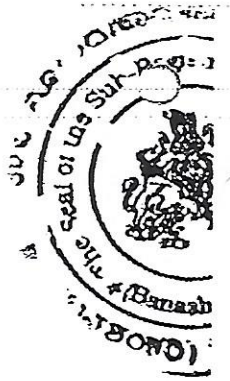

1. - b) The Name of the Trust shall be "Smt. Gayathri M Krishnappa Educational and Charitable Trust".
- c) The Registered Office of the Trust shall be situate in the first instance at No.196, 16th Main, 24<sup>th</sup> Cross, Banashankari 2<sup>nd</sup> Stage, Bangalore-560070. The office of the Trust may be shifted to any other place/s as may be decided upon by the Board of Trustees. The Board of Trustees shall be entitled to establish, run, and maintain Branch Office/s at such places as may be determined by them from time to time.

**OBJECTS OF THE TRUST**

**MAIN OBJECTS :**

- A) To establish run, aid assist, maintain, support and promote the advancement of educational activities in all its branches, such as Kinder-garden, Primary schools, Middle Schools, High Schools, Colleges, leading upto Degree, Post Graduate and Doctorate courses in Arts, Science, Commerce, Engineering, Medicine, Pharmacy, Dental, Nursing, Management, Music and Fine Arts, Architecture and such other



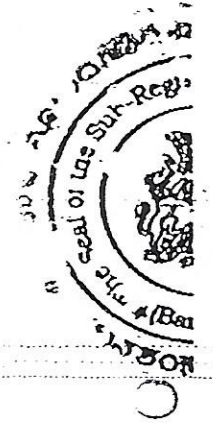

- c) Awarding scholarships and other financial assistance to students,

- e) Grant of adhoc or annual financial assistance to educational institutions, institution of scholarships, prizes, medals, rewards and endowments for excellence in studies and scientific research, grant of tuition fee, books, stationery and food, free of cost or at concessional rates, to poor and/or deserving boys and girls to prosecute educational courses in India.

- g) To assist financially or otherwise any institutions, which are doing things in furtherance to the objects of this trust and in such manner as the Trustees may determine in this regard.
- h) To establish, maintain, manage hostels, library, reading room sports complexes, yoga and cultural centers, boarding and lodging facilities to the students.

**4. THE TRUST IS HEREBY DECLARED IRREVOCABLE :**

The AUTHOR of the trust hereby expressly further declares that he neither reserves any rights to revoke the trust nor any benefits either directly or indirectly for the trust under any circumstance.

**5. TRUSTEES, BOARD OF TRUSTEES AND THEIR CONSTITUTION:**

- a. The AUTHOR of the Trust does hereby constitute, nominate and appoint the Parties of the SECOND PART as the FIRST TRUSTEES or the PERMANENT TRUSTEES or the BOARD of TRUSTEES of the TRUST. The TRUSTEES hereby appointed shall hold office as TRUSTEES for their life.
- b. The BOARD OF TRUSTEES shall appoint any one or more of their body to the office of the Chairman, Vice – Chairman, President, Vice – president, Treasurer and Secretary of the Trust and entrust with such rights and powers in relation to the conduct of the Trust and its affairs as needed.
- c. The BOARD OF TRUSTEES shall have the power to co-opt any other person to the BOARD for such period/s as they deem fit. However the total number of Trustees shall not exceed 10 (Ten only).

6. POWER OF THE BOARD OF TRUSTEES :

With a view to carry out the objects of the Trust hereinabove mentioned and to augment its funds and administer them and in discharge of their duties, the BOARD OF TRUSTEES shall have the following powers:

- i) To manage, run, establish, maintain, conduct and administer any school, college, institutions in fulfillment of the objects of the Trust under any name as the Trustees may decide from time to time.
- ~~ii) To receive any monetary or other assets and properties in any shape or form as and when given by the author of the Trust or any other persons as gift, donation and endowments and to hold the same as part of the capital fund or corpus of the Trust, if such donor expresses his/her desire to treat the same or to make it available for the application to further objects of the Trust.~~
- iii) To collect funds by way of donations, subscriptions, grants, presents contributions and other form of offerings so as to augment the Trust funds for applications towards the objects of the Trust or to make donations or contribution or otherwise apply the Trust funds towards objects of the Trust.
- iv) To acquire on lease or by purchase or otherwise and to sell, mortgage, to lease out or transfer in any other manner, properties, movable or immovable and to construct buildings, manage and to deal with such properties and all other assets of the Trust and to pledge, hypothecate or otherwise create a lien over them to raise funds, and to deal generally with the assets for the purpose of achieving the objects of the Trust.
- v) To acquire land, construct such buildings, which yields money to maintain the institutions to fulfill the objectives of the Trust.

- vi) To receive, collect, realize or cause collections, realisation of all interest, dividends, bonus or premium that accrues or becomes due on all or any of the stock, funds, securities, debentures or deeds or documents of like nature.
- vii) To represent the Trust in all courts or before any other authorities and departments of Governments, Semi- Governments, local authority or any other statutory bodies in respect of Trust matters.
- viii) To execute or negotiate all the necessary papers and documents whether negotiable or non - negotiable and to receive money or other assets and to grant receipts and discharge in respect thereof.
- ix) To sign and verify all pleadings, memorandum of appeal, petitions and applications of all kinds of compromise and/or refer to arbitration, the whole or any part of the claim by or against the Trust and to engage lawyers or other professionals and to take all such other necessary steps.
- x) To borrow for the purpose of the Trust on personal credit of the Trust with or without charge or lien and responsibility upon the assets of the Trust.
- xi) To meet all the necessary expenses incurred or to be incurred in connection with the creation and execution of this Trust.
- xii) To open and maintain accounts of any nature in any bank/s of their choice and authorize operations of the said accounts by the member/s of the BOARD OF TRUSTEES jointly or severally.

- xiii) The **BOARD OF TRUSTEES** shall have the power to appoint or nominate for such period as they deem fit, out of them a President, Secretary and Treasurer. The Board shall also have the power to appoint or nominate one of them as the Chairman, vice chairman or Managing Trustee.
- xiv) The **BOARD OF TRUSTEE** by way of a resolution be entitled to delegate all or any of the powers vested with them and determine the powers of the President, secretary, treasurer, chairman, vice chairman or the Managing Trustee to discharge such functions and duties.
- xv) The power enumerated above shall be exercised by the **BOARD OF TRUSTEES** subject to their satisfying the conditions laid down under section 11, 12 and 13 of the Income Tax Act, 1961 (43 of 1961) as amended from time to time, so that the Income of the Trust will be exempt from Income Tax for each and every assessment year and/or such donations to the Trust qualify for deductions under sections 80- G, 35, 35AC, 35CCA, 35CCB and/or such other sections of the Income Tax Act 1961 wherein the exemptions are available in future amendments or reenactments, in the hands of the donors.
- xvi) The powers vested in the **BOARD OF TRUSTEES** shall be exercised according to the decision of the majority of the members of **BOARD OF TRUSTEES** and by way of resolution passed either by circulating or at the meeting of the **BOARD OF TRUSTEES**.
- xvii) To do all other acts, deeds, matters and things which may be deemed necessary and expedient for carrying out the objects of this Trust or its administration. The Chairman, Vice – Chairman, President, Vice – President, Treasurer or Secretary of the

Trust shall have power to incur expenditure for running the administration of the office of the Trust in accordance with powers delegated to them.

xviii) To frame rules and regulations with regard to the schools, colleges, institutions being run by the Trust in conformity with statutory requirement for such administration and governance.

**7. CORPUS OF THE TRUST:**

The ~~CORPUS of the TRUST~~ shall mean and include the sum of Rs. 1000/- (Rupees One Thousand only) declared as the Trust property and all other funds and investments for the time being representing the same. It shall also include such gifts, donations, endowments as may be received from the AUTHOR of the TRUST and also such other amounts held by the Trustees or the Board to be held under the specific direction and terms and that they shall be kept as part of the CORPUS of the TRUST and also the investments for the time being, representing the same. It shall also mean and include any other sum specifically required to be kept as part of the CORPUS of the TRUST.

**8. TRUST FUNDS OR TRUST PROPERTY:**

Trust funds or property shall mean and include not only the corpus of the Trust but also the income arising to the Trustee/s which remains unapplied or accumulated for application towards the objects by keeping and treating it as part of the corpus of the Trust and all the investment for the time being representing the same.

It shall also include all the assets, tangible and intangible benefits and rights acquired during the existence of this fiduciary obligation for the benefit of the trust and also the investments and proceeds representing the same for the time being. It shall also include

funds coming into the possession of the trustees in the course of the administration of the trust and all the investments for the time being representing the same.

9. The **PRESIDENT** or the **SECRETARY** of the **BOARD OF TRUSTEES** may convene the meeting of the **BOARD OF TRUSTEES** by serving notices of the meeting on the other members of the **BOARD OF TRUSTEES** in writing and setting out therein the matters to be discussed and the place of the meeting, the day, date and time of the meeting.

10. The office of the Trustees or the members of the **BOARD OF TRUSTEES** as the case may be, shall be honorary and any person holding such office shall not be entitled to draw any remuneration for carrying out their duties, but shall be entitled to be paid their actual traveling expenses and other incidental charges incurred by them for attending the meeting of the **BOARD OF TRUSTEES** or attending to the work of the Trust.

11. The **BOARD OF TRUSTEES** shall meet from time to time but not later than 3 (Three) months from the date of meeting held last and as and when necessary to transact issues and for considering the betterment of the Trust and its assets.

12. **Quorum, Notice etc ;**

- a) The quorum for the meeting of the **BOARD OF TRUSTEES** shall be 3 (Three).
- b) Notice of all meetings of the **BOARD** shall be sent to every member of the **BOARD OF TRUSTEES** either by electronic mail, post or otherwise and for this purpose the post communication addressed to the members of the **BOARD OF TRUSTEES** shall be deemed to be sufficient notice.

13. The BOARD OF TRUSTEES shall cause true and correct accounts to be kept of the sums of money received and expenditure incurred on behalf of the Trust at least once in every year. The accounts of the Trust shall be examined and correctness of the accounts and the Balance sheet shall be examined and audited by a chartered accountant appointed by the BOARD and shall be countersigned by the BOARD OF TRUSTEES.
14. The BOARD OF TRUSTEES shall have power to make rules and regulations with regard to the conduct of the affairs of the Trust and all matters in respect of duties vested with them as they may think fit and also have power to alter, modify, delete and amend them from time to time. None of the rules shall be inconsistent with the objects of the Trust or the powers or clauses contained in these presents.
15. The funds and income of the Trust shall be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to TRUSTEES, by way of profits, dividends, interest etc.,
16. The BOARD OF TRUSTEES shall be indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the Trust and such expenses, losses and payment shall be borne by the Trust and none of the Trustees or the members of the BOARD OF TRUSTEES as the case may be shall, in any way, be personally liable or responsible for the same.
17. The BOARD OF TRUSTEES shall be chargeable only for such money or securities as they shall actually receive and shall be answerable and accountable for their own acts, receipts, neglects or defaults and not those of others particularly of any banker, broker or auctioneer or other person with whom or into whose hands any Trust moneys or securities may be deposited for insufficiency in title or deficiency in value of any investment or for

any investment for any other loss unless the same shall happen through his willful act or default.

18. The BOARD OF TRUSTEES may reimburse themselves or pay and discharge out of said Trust properties the expenses incurred by them in or and for the execution of the Trust and powers as mentioned in these presents.
19. The BOARD OF TRUSTEES shall have the power to alter, modify or delete any of the terms of the Trust Deed, from time to time, so as to realize the objects of the Trust effectively. However, such modification and amendments to the Trust Deed shall not be so effected so as to bring about a change in the basic structure of the Trust or in any way render the Trust disentitled to get the recognition under section 80G, 35, 35AC, 35CCA, 35CCB or other such sections of Income Tax Act, 1961 or denial of exemption under Income Tax under 11, 12 & 13 of the Income Tax Act, 1961. Further no amendments shall be carried out without the prior approval of the jurisdictional Commissioner of Income Tax or the appropriate authority under the Income Tax Act.
20. The Funds of the Trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961 as amended from time to time.
21.
